- Reducing and preventing risks of harm.
- Working to ensure the safety and empowerment of vulnerable individuals and communities.
- Recognizing the human rights of all persons and working to prevent and address violations of those rights.



Why is safeguarding important?

- Respects and acknowledges the dignity of our neighbors, our fellow Vincentians, and ourselves.
- Respects the right of a person to create a safe environment, especially in their homes and communities.
- Keeps members safe from false, malicious, or exaggerated claims.
- Maintains the reputation of St. Vincent de Paul.

National Safeguarding Policy

- The policy seeks to address safeguarding as it applies to:
 - Children and young people.
 - Other vulnerable people, acknowledging that people could be vulnerable to abuse or neglect by reason of their age, physical or mental disability, or poverty and reliance on social services.
- National SVdP requires all Councils to be in compliance with their Archdiocesan policy.



To remain in compliance, you must:

Option A

Complete SafeParish through the Archdiocese/Parish.

Option B

Complete safeguarding training offered through St. Vincent de Paul – Cincinnati.

Option C

Do not work with children or vulnerable adults more than six times per year.
